### Crypto and blockchain experience

In 2019, KGSA advised the issuer on the first successful initial coin offering (ICO) in Portugal.

Since then, we have been at the forefront of the blockchain and crypto market in Portugal and are often called upon to create novel legal solutions. Most of the matters we work on are confidential, but we have included examples of our experience below.

- > Advising Portuguese and Estonian crypto issuers on the issuance of tokens and their admission to crypto exchanges, including by reviewing their qualification as securities in Portugal and the United States (with local counsel), issuing "token legal options", reviewing white papers, and drafting token terms and conditions, selling restrictions, and simple agreements for future tokens (SAFTs).
- > Advising (with local counsel) Portuguese clients in credit claims to recover crypto and cash investments in the context of the bankruptcy of BlockFi in the United States and Coinloan in Estonia.
- > Advising crypto issuers and investors on the treatment of crypto assets for personal and corporate tax purposes in Portugal, including by securing a landmark ruling by the Portuguese tax authorities on the non-taxation of crypto capital gains for personal tax purposes.
- > Counsel (with local counsel) to the complainant, a Portuguese resident, in a dispute involving the delivery of crypto assets in the British Virgin Islands, a first in the territory.
- > Advising software firms on contractual arrangements in connection with the development of "smart contracts" on the Ethereum blockchain.

### Crypto and blockchain experience

- > Advising Polkamarket on the establishment of "Previsómetro", a prediction market tracking the 2024 Portuguese general election results (<u>available at the Observador newspaper</u>) with over 100,000 visits within the first days of launching, and the issuance of the project's own utility token (VOZ Token).
- > Advising corporate and private investors in connection with investments in crypto assets (review of regulatory restrictions, negotiation of SAFTs and other contractual arrangements, and tax and corporate structure advice), in Portugal and (with local counsel) the United States, Luxembourg, Singapore, and several offshore jurisdictions.
- > Advising a Portuguese crypto issuer on a capital reduction resulting in a return of crypto assets.
- > Assisting Portuguese crypto issuers in retaining access to the Portuguese banking system and assisting several Portuguese and foreign investors in crypto assets in connection with KYC/AML checks and source of funds confirmations performed by banks and other providers.
- > Advising a Portuguese private equity firm in connection with distributions of crypto assets issued by a portfolio firm.
- > Advising a DeFi company on the regulatory and contractual implications of adding a crypto currency trading feature to its product offering.
- > Advising Portuguese and Estonian crypto issuers in connection with employee share ownership programmes, and grants and other token disbursement programs/schemes.

### Tech and blockchain M&A experience

Alongside our regulatory and transactional crypto practise, we have been involved in a number of the tech and blockchain M&A transactions taking place in Portugal or involving Portuguese players, including:

- > Advising Portugal's Exclusible, the leading luxury NFT platform, on the acquisition of Polycount, a United States-based metaverse architectural design studio, in a landmark metaverse and web3 deal.
- > Advising Bepro on the sale of Bepro Network Labs to TAIKAI, a hackathon platform used by more than 50,000 developers. The deal was <u>reported as creating "a Portuguese blockchain giant"</u>.
- > Advising the founders on the widely reported incorporation and pre-seed investment round of Doppl, dedicated to the development of digital doppelgangers through the use of artificial intelligence.
- > Advising Estonia's Chain Protocol Labs on the acquisition of Portugal's Betblock, a company developing decentralised blockchain protocols, from venture capital firms Shilling Capital Partners, Ganexa Capital, Blockground Capital, Busy Angels and the founders.
- > Advising Chain Protocol Labs on the spin-off and sale (in the context of a management buy-out) of Polkamarket, a blockchain firm using DeFI and information exchange to create prediction markets, focused on sports, esports and election polling.
- > Advising Portal da Sabedoria on its combination with Student Hub, creating the largest Portuguese online learning platform.

#### Other M&A experience

In parallel, we have also led M&A and corporate transactions in other sectors, including:

- > Advising Sanitop, a construction materials and HVAC market leader in Portugal on the acquisition of Pinheiro & Santos, specialised on the sale of electric materials, in what was Sanitop's first M&A transaction.
- > Advising Sanitop on the acquisition of Bifase Eletric, a Portuguese distributor of electric and electronic materials, which will allow Sanitop to reach €100 million in revenues.
- > Advising the shareholders of Psicoespaço, a leading mental healthcare provider, on the sale of a minority stake to Spanish private equity firm Q-Impact.
- > Advising a family office on the restructuring of its corporate vehicles in Portugal and abroad, including the incorporation of a real estate investment company, the acquisition of a real estate portfolio and an investment into a private equity fund.
- > Incorporation of Fundação UNITATE, a foundation focused on the social economy, which has since trained thousands of third sector workers and won a BPI-Fundação "la Caixa" award.

- > Incorporation of Santa Casa da Misericórdia de Quarteira, the first to be established in the 21st century in the Algarve.
